- ❖ **Students successfully passing the driving exam may be required to be retested by the Tennessee Department of Safety at its sole discretion.**
- ❖ We do not guarantee a permit or license just because you took our course, students must pass all the State Requirements. This contract represents the entire agreement between the parties and can only be amended in writing.

Basic Course Package: (This course is Accepted by All Insurance Companies that offer a Driver's Education Discount)

30 hours classroom & 6 hours behind-the-wheel is \$375.00

This class is for students who already have their learner permit or license.
There is no 3rd party testing for this course, test must be taken at the Driver Testing Station.
Driving dates and times to be scheduled with parents and instructor before the last day of classroom.
A Certificate of Completion is issued for insurance purposes after completion of classroom and driving time.
Check with your insurance company to find out how much you can save.

➤ You may reserve a place for your teen by sending a \$25 non refundable deposit. The balance is payable on the first day of class.

Deluxe Course Package: (This course includes: testing for either learner permit or license for students that are eligible to take the test and Certificate of Completion for insurance purposes)

30 hours classroom & 6 hours behind-the-wheel is \$399.00 – (10% discount for AAA Members is \$360.00)

STUDENTS 15 OR OLDER BY THE LAST DAY OF THE CLASSROOM ARE ELIGIBLE TO TAKE THE TEST FOR LEARNER PERMIT.
(Anyone under the age of 18 must hold a permit for 6 months and be at least 16 years old before they are eligible to apply for a license.)

UPON SUCCESSFULLY PASSING THE TEST, THE STUDENT WILL BE ISSUED A 3RD PARTY CERTIFICATE (Exempts you from taking the test at Driver Testing Station).
THE CERTIFICATE CAN BE TAKEN TO THE DRIVER TESTING STATION WITH PARENT AND STUDENT'S BIRTH CERTIFICATE, PROOF OF SOCIAL SECURITY, SCHOOL COMPULSORY ATTENDANCE FORM TO OBTAIN THEIR LEARNER PERMIT. THEN CONTACT OUR OFFICE TO HAVE YOUR NAME ADDED TO THE DRIVING SCHEDULE.

STUDENTS WHO ALREADY HAVE THEIR LEARNER PERMIT WHO ARE 15-1/2 OR OLDER BY THE LAST DAY OF CLASS ARE ELIGIBLE TO TAKE THE TEST FOR THEIR LICENSE
AFTER THE DRIVING PORTION. UPON SUCCESSFULLY PASSING THE TEST, A 3RD PARTY CERTIFICATE WILL BE ISSUED AND CAN BE TAKEN TO THE DRIVER TESTING STATION WHEN STUDENT HAS HELD A LEARNER PERMIT FOR 6 MONTHS AND IS AT LEAST 16 YEARS OF AGE. (A 3RD PARTY CERTIFICATE IS GOOD FOR 180 DAYS (APPROXIMATELY 6 MONTHS).

A CERTIFICATE OF COMPLETION FOR INSURANCE PURPOSES WILL BE ISSUED AFTER COMPLETION OF THE DRIVING PORTION OF THE COURSE.
